Petition

The face of the LORD is against them that do evil...
KJV Ps.34:16

We, Evangelical Christians-Baptists, inform you, that on July 20, 2009, at 11:45 PM, the house where the family of Alexander and Lyudmila Kozlovs lived, without warning, the authorities: Detective M. La Crosse-Primary, Detective T. Burwell-Assisting, Deputy J. Wollenschlaeger-Initial, Deputy A. Lucca Assisting, DHS case worker Ms. Miller, DHS Brenda Kumm, District Attorney DDA J. Bureta, Sergeant Adcock arrived, - and without a court order, minor children of the spouses Kozlovs, including daughter Lily Kozlova, which was six days, were forcibly taken from home and isolated from their parents.

Newborn Lily Kozlova was forcibly deprived of feeding with maternal milk, which is anything irreplaceable and protecting the child from various diseases. For sixteen days, Lyudmila Kozlova spent in prison, she lost the ability to produce milk that is necessary to feed the baby. On July 30, 2009 by order of the Department of Human Services (DHS), Lily Kozlova was vaccinated with "Hepatitis B", without having any oral or written permission from her parents. - Because of the illegal actions of the authorities, Lily Kozlova, who was born in the United States, a U.S. citizen, was deprived of privileges and benefits, set forth in the United States Constitution, Amendment XIV:

"Section 1. All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws."

Parents Alexander and Lyudmila Kozlovs nothing illegal had committed both in the family and in the society and the state.

According to the church charter (§ 35) of the International Union of Churches of ECB, whose members are Alexander and Lyudmila Kozlovs, they have the right to "bring them up in the nurture and admonition of the Lord (Eph.6:4) and apply to their children the moderate punishment for purposes of education in accordance with biblical teaching (Prov.13:24; 23:13-14; Heb.12:6-8)."

The emergent in the family conflict, provoked by elder children, was used by the colleagues of the Department of Human Services (DHS) against the family of Kozlovs, and all further actions of the representatives of authority facilitate not to the reunification of elder children with the parents, but, on the contrary, to alienation. Specifically, for the purpose of alienation all was made, so that the parents Alexander and Lyudmila Kozlovs would not meet before the court with elder children as the witnesses of the conflict.

The authorities presented the produced charges in such way that they are, allegedly, were based on the testimonies of minor children of Kozlovs. But that is exactly what arouses the legal suspicion of their authenticity and of the methods by which these statements could be obtained from children.

Amendment VI of the Constitution of the United States says:

"...The accused shall enjoy the right... to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor..." - This right to confrontation with their children as witnesses who testified against their parents, accused Alexander and Lyudmila Kozlovs were denied, which is also a flagrant judicial tyranny.

We petition for the immediate release of Alexander Kozlov (SID # 18068271) and Lyudmila Kozlova (SID # 76223984) from detention as the innocent prisoners and not to prevent the restoration of a large Christian family.
