Petition

*How long will ye judge unjustly,
 and accept the persons of the wicked?*
 Psalms 82:2

We, Evangelical Christians-Baptists, united by the service under the International Council of Churches (ICC ECB), would like to inform you of a crime being committed by the public officials of Oregon in regards to imprisoned Christian parents Alexander and Lyudmila Kozlov, who are categorically against voluntarily giving up their children for adoption to any family.

In addition, long before the trial scheduled for December 12, 2011, officials explicitly declared to Alexander and Lyudmila that the outcome of the trial will be the following: the children will still

be adopted without the consent of the parents, parental right of the Kozlovs will be taken away, and they will lose the trial.

In order to justify the decision of depriving Lyudmila Kozlov of her parental rights, Oregon state officials have put forward a number of trumped-up, slanderous accusations, some of which say that she suffers from "mental deficiency" and "is unable to care for children."

We cannot exclude the fact that such actions by state officials of Oregon are directed to discredit the parents of this large Christian family, who has already suffered much from the arbitrary action of state officials, presenting them as criminals in the eyes of the public in order to disguise the crime committed by government officials against Alexander and Lyudmila Kozlov and their children.

On July 20, 2009, 11:45 PM, officials broke into the Kozlov house: **Detective M. La Crosse-Primary, Detective T. Burwell-Assisting, Deputy J. Wollenschlaeger-Initial, Deputy A. Lucca-Assisting, DHS case worker Ms. Miller, DHS Brenda Kumm, District Attorney DDA J. Bureta, Sergeant Adcock**, - and peacefully sleeping children, six-day old Lily Kozlov, nine-year-old Natasha Kozlov, ten-year-old Vova Kozlov, and eleven-year-old Alona Kozlov, were woken, taken from their beds, and frightened and against their will, they were taken from home and separated from their parents. This is a crime!

While in custody, Lyudmila Kozlov was forcibly deprived of the opportunity to continue to breast feed her new-born daughter Lily Kozlov breast milk. As a result of spending sixteen days in jail, as a nursing mother, she lost the ability to produce milk needed to feed the baby. This is a monstrous crime committed against the life and health of an infant and a nursing mother!

You have been repeatedly informed on the judicial injustice of this trial.

We believe that there is no ground based on which the Kozlov parents should be deprived of their parental rights and we petition:

- to provide the Kozlov parents the opportunity to freely communicate with their children by telephone;
- not to deprive Alexander and Lyudmila Kozlov of their parental rights;
- to remove all false accusations of unlawfully convicted Alexander Kozlov (SID# 18068271) and Lyudmila Kozlov (SID# 76223984);
- to prevent the adoption of Kozlov children to any family and to not stand in the way of uniting this large Christian family;
- to immediately release Alexander and Lyudmila Kozlov as innocent prisoners.





Please consider the present petition as an informative message of the lawless actions of state officials and of abuse of justice.
